ACTIVE! Dog Daycare and Boarding Policies, Procedures and Release/Waiver Agreement

Read carefully: Be aware that by signing this agreement, you will be expressly waiving and releasing all claims that you may have against ACTIVE! Dog Daycare and Boarding and its owners, directors, officers, employees, agents, and all other persons or entities acting for them (who collectively may be referred to herein as "ACTIVE!") related to injuries, damages, or loss that you or your dog may sustain while your dog is under the care of ACTIVE!, and you will be assuming all risk and legal liability associated with placing your dog under ACTIVE!'s care

- 1. Acknowledgment and Assumption of Risk.** I acknowledge that dog daycare, walking, and boarding services and all other services provided by ACTIVE! (the "Services") require human-to-dog and dog-to-dog interactions that involve known and unanticipated risks, which could result in physical injury to myself and my and other dogs, and to ACTIVE!'s employees and agents, as well as property damage. I understand such risks simply cannot be eliminated, despite the use of reasonable safety procedures and equipment, without jeopardizing the essential qualities of the Services. I expressly accept and assume all of the risks inherent in the Services or that might have been caused by the negligence of ACTIVE!, and understand that I am responsible for any injuries, whether to humans or other animals, or property damage caused to or by my dog while my dog is attending daycare at ACTIVE! or is otherwise under the care of ACTIVE!. Placing my dog in ACTIVE!'s care is purely voluntary and I elect to do so despite the aforementioned risks.
- 2. Release.** I hereby voluntarily waive, and release and forever discharge ACTIVE! from, any and all claims, demands, or causes of action (collectively, "Claims") which are in any way connected with ACTIVE!'s provision of the Services to my dog, including Claims for injuries to myself and my dog, up to and including the death or disability or myself or my dog, notwithstanding the fact that such Claims may be the result of ACTIVE!'s negligence. I understand that items brought for overnight stays may be damaged/destroyed and that ACTIVE! shall not be responsible for such damage/destruction.
- 3. Indemnification.** I indemnify and hold harmless ACTIVE! from any and all liabilities and expenses (including any reasonable attorney's fees) incurred by ACTIVE! or Claims against Active as a result of my or my dog's actions. If ACTIVE! is required to incur attorney's fees and costs to enforce this agreement, I agree to reimburse, indemnify, and hold ACTIVE! harmless with respect to such fees and costs.
- 4. Treatment of Injuries and Illnesses.** I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by ACTIVE! in its sole discretion. Either my veterinarian or a veterinarian selected by ACTIVE! will be contacted in the event of a medical problem that is serious in nature. I agree that I am fully responsible for the costs of any such medical treatment. If my dog should become ill or seem to be in need of medical consideration, ACTIVE! reserves the right to administer aid and/or to use any available veterinarian. I, the owner, shall pay any expenses so incurred. I understand that when dogs play in group's nicks and scratches may occur. Daycare staff may or may not notify me immediately. If the injury is not serious the staff can let my dog continue to play and let me know about it later.
- 5. Disclosure of Medical and Behavioral Issues.** I have informed ACTIVE! of any conditions my dog may have that may affect its interactions with people or other dogs, such as illness or aggression problems, and understand and agree that in admitting my dog to ACTIVE!, ACTIVE! has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog. While I represent that my dog is not aggressive, I understand that if he or she behaves aggressively or displays behaviors deemed unacceptable by ACTIVE!, he/she will be removed from the play group. If ACTIVE! deems my dog a danger to himself/herself or others, my dog may be asked not to return. Such determinations will be made at the sole discretion of ACTIVE!.
- 7. Limitation of Liability.** In no event shall ACTIVE!'s liability to me exceed the lesser of: (a) the current value of my dog and (b) \$400.
- 8. Use of Image.** I understand that ACTIVE! loves to take pictures and videos of the dogs during play time. I consent to ACTIVE!'s use of my dog's likeness in pictures and videos on its website, all social media, and other marketing materials.

8. **Miscellaneous.**

- A. I understand ACTIVE's provision of the Services requires dogs to comingle in groups. I understand my dog may be placed in a kennel for "time outs" not to exceed fifteen minutes if its behavior is unacceptable or if it becomes overexcited.
- B. I understand that if my dog is left under ACTIVE!'s care for three days without reservations or contact from me, the dog will be considered abandoned and necessary steps will be taken to turn the dog over to the proper authorities.
- C. I agree to have my dog's collar on in ACTIVE!'s care, which includes a name tag as well as City of Chicago tags.
- D. I understand that if I do not bring my dog to ACTIVE! for daycare or boarding for a period of six months or more, my dog will have to re-interview and I will be responsible for paying for a day of daycare.
- E. I agree that this agreement shall be binding on me and my successors, heirs, assigns & legal representatives.
- F. The interpretation and enforcement of this Agreement shall be governed by the laws of the state of Illinois without regard to its conflict of law principles. If any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
